

RIWAYAT HIDUP / CURRICULUM VITAE

HORST SIEGFRIED GÜNTHER

Warga negara German dan penduduk tetap (permanent residence) di Singapura lahir pada tahun 1959. Memiliki profesionalitas tinggi dan sangat berpengalaman di industri agribisnis sebagai seorang Konsultan Independen.

Bapak Horst Siegfried memulai karirnya sebagai karyawan magang di Alfred C. Toepfer (kemudian menjadi Toepfer International) di Hamburg sejak 1980 sampai 1982, kemudian pada tahun 1982 beliau diangkat menjadi karyawan pada Departemen Perdagangan Tepung Tapioka.

Sejak bergabung dengan Alfred C Toepfer, beliau telah menduduki berbagai posisi strategis di perusahaan, termasuk sebagai *Deputy Branch Manager* di Bombay (1983), *Sole Representative* di Jakarta (1984), *Area Trade Director for Asean / Indo-China* di Singapura (1988), *Branch Manager* di Mumbai (1989), Direktur untuk wilayah Jepang (1992), *General Manager* untuk area operasional Jakarta sekaligus bertanggung jawab untuk mengembangkan wilayah Indochina (1992).

Pada bulan Maret 1993, beliau pindah ke Continental Grain Company di Hongkong dan bertanggungjawab atas perdagangan bahan baku di wilayah Asia Tenggara. Pada tahun 1999, perusahaan diambil alih oleh Cargill International, dimana kemudian beliau bergabung dan pindah ke Singapura.

Pada tahun 2000, beliau bergabung ke Bunge Limited di Singapura dan diangkat menjadi *Trade Manager* untuk *Oilseed* dan *Feedstuff* di wilayah operasional Asia Tenggara.

Pada tahun 2010, beliau diangkat menjadi CEO untuk Marubeni Grains and Oilseed Trading Pte Ltd di Singapura sampai tahun 2016 dan terus berkontribusi sebagai Konsultan Eksklusif sampai akhir tahun 2017 sebelum akhirnya beliau berkarir sebagai Konsultan Independen di industri agribisnis.

A German citizen and permanent residence in Singapore born in 1959. Highly professional and experienced in the agribusiness industry as the Independent Consultant.

Mr. Horst Siegfried started his career as apprentice in Alfred C. Toepfer (which became Toepfer International) in Hamburg from 1980 until 1982 and in 1982 He was appointed as the employee in the Department Tapioca Trade.

Since joining Alfred C. Toepfer, He has held a number of strategic positions in the company, including Deputy Branch Manager in Bombay (1983), Sole Representative in Jakarta, Indonesia (1984), Area Trade Director for Asean / Indo-China in Singapore (1988), Branch Manager in Mumbai (1989), Director for the Japan operations (1992), General Manager for Jakarta operations as well as being responsible to develop the Indochina region (1992).

In March 1993 He moved to Continental Grain Company in Hong Kong and was responsible for their feedstuff trading operations in South East Asia. In 1999 the company were bought over by Cargill International, He joined them and then moved to Singapore.

In 2000 He joined Bunge Limited in Singapore and became their Trade Manager for the Oilseed and Feedstuff operations in South East Asia.

In 2010, He was appointed as CEO for Marubeni Grains and Oilseed Trading Pte Ltd in Singapore until 2016 and worked for them as Exclusive Consultant until the end of 2017 prior becoming Independent Consultant in agribusiness industry.
